Interpretation

1. (1) In this order,

"G.E.D. tests" means a set of five tests administered for the purpose of determining a level of basic skills in literacy, numeracy and comprehension of a person who

- (a) is older than school age,
- (b) has not been enrolled in an educational program for at least one school year, and
- (c) has not completed the graduation requirements set out in any graduation program; and

"certificate" means a certificate issued to a person who has passed the G.E.D. tests.

(2) All fees set out in this order include any HST that is payable.

Test fee

2. (1) A fee of \$60 must accompany an application to write G.E.D. tests.

(2) If an application is made to rewrite one or more of the G.E.D. tests, it must be accompanied by the following fee:

- (a) \$40 for a request to rewrite 1 test;
- (b) \$45 for a request to rewrite 2 tests;
- (c) \$50 for a request to rewrite 3 tests;
- (d) \$55 for a request to rewrite 4 tests; or
- (e) \$60 for a request to rewrite 5 tests.

Rereading fee

3. (1) A person who writes the G.E.D. tests may request to have one or more of his or her G.E.D. tests reread.

(2) If a request is made under subsection (1), the request must be

- (a) made in writing, and
- (b) accompanied by a fee of \$15 for each test paper that is to be reread.

Fees for additional transcripts and certificates

4. (1) A person requesting that the Ministry of Education provide a transcript of marks from the G.E.D. tests, or a certificate, must submit a written request together with a search and copy fee of
 - (a) \$10, or
 - (b) \$25, if the provision of the transcript or certificate is required within 24 hours of the request being received by the Ministry.
- (2) The fee for additional copies of a transcript or certificate requested when the search is made, is:
 - (a) \$5 for each additional transcript requested,
 - (b) \$10 for each additional certificate requested, and
 - (c) \$25 for each additional transcript or certificate requested within 24 hours.
